The following ranking refers to the selection procedure for the recruitment of 1 Program Officer – Government Liaison Officer, a vacancy notice for which was published on the AICS website on 21/08/2020, expired on 21/09/2020 at 17.30 - Myanmar local time.

According to the provisions of point 5 of the Selection Notice *"After the interview, the Evaluation Committee draws up the final ranking list of eligible candidates, including only candidates who have been awarded with a minimum overall score of 60 points (preferred requirements and interview points combined)"*.

As per the Evaluation Committee Selection Report, approved on 2/12/2020, the final ranking of eligible candidates is as follows:

In case the winning candidate declines the contract offer or in case of early termination of the contract by any of the parties, AICS Yangon reserves the right to appoint the candidate with the next highest score as long as financial resources are available. In case of a tied score, the youngest candidate is preferred in accordance with Italian recruitment law. The ranking list of final eligible candidates is*
